## - PROCEDURE -

### - PRE-REGISTRATION - COMMITMENT and PAYMENT MODALITY

#### A) - PRE-REGISTRATION

##### 1 DATES

**THURSDAY, MARCH 01, 2018**

At 21: 00 -Opening of pre-registrations.

**MONDAY, MARCH 05, 2018**

At 24: 00 -Closure of pre-registrations.

**MONDAY, MARCH 12, 2018**

Application deadline for full payment of entry fees. The date of the postmark or the date of registration of the transfer being authentic.

##### 2. PROCEDURE

- On the dates and times mentioned above, access through our site [www.mclivradois.org](http://www.mclivradois.org), section **RAND'AUVERGNE**, to a blank sheet of pre-registration to be duly completed by the interested.
- Capture successful, a preregistration number. Conservation of it until the day of administrative control.

### C) - AMOUNT ENTRY FEES - REFUND:

## - PROCEDURE -

### 2 – DEFECTION, REFUND:

- Defection:

Admissible to the United Nations **by registered letter** (postmark) **or email up to the 06 June 2018** included.

- Reimbursement of entry fees:

Will be either:

- By the destruction of the cheque issued during pre-registration.
- By sending a cheque.
- By executing a bank transfer for non residents on French soil.

**The admissibility of the defection time spent, refund won't be taken into account by the host club regardless of the reason.**

### (D) - additional important NOTIFICATIONS:

- The Organizing Committee reserves the right to refuse the entry of a competitor without having to explain why (article 74 of the C.S.I. (*International Sporting Code*)).
  - *No possible commitment verbally, by telephone, on paper or by e-mail.*
  - *In any case, a driver may exchange its commitment with another pilot.*
- *For residents off of the French territory and not licensed to the F.F.M: (Rév.1)*
- *1) - National or international foreign license holders will be required to present with the latter, during the administrative checks of the test, a **written authorization to leave from their federation**. In the absence of this document they must, if they wish to participate in the event, subscribe to a license "event day" (Cf. §-IV - **section 6 - page 6/12** of the particular regulation of the event).*
