FRIDAY, MARCH 10, 2017

Application deadline for full payment of entry fees. The date of the postmark or the date of registration of the transfer being authentic.

2. PROCEDURE

2 DEFECTION, REFUND:

-Defection:

Admissible to the United Nations by registered letter (postmark) or email up to the 07 June 2017 included.

-Reimbursement of entry fees:

Will be either:

- -By the destruction of the cheque issued during pre-registration.
- -By sending a cheque.
- -By executing a bank transfer for non residents on French soil.

The after period of admissibility of defection, no refund is will be taken into account by the host club.

(D) - additional important NOTIFICATIONS:

- The Organizing Committee reserves the right to refuse the entry of a competitor without having to explain why (article 74 of the C.S.I. (*International Sporting Code*).)
